“2020-21 Reopening Plan – Phase 4”

Stage 1: Implementation

This reopening plan will run from the start of the 2020-21 school year until the end of the first quarter (October 23). Based on the new realities at that point, this plan will either be extended to cover the second quarter, or altered to reflect the new environment.

Staff Training:

- Staff will undergo professional development in the following areas:
 - Understanding and implementing the Fall Reopening Plan
 - Sanitation and disinfection of classrooms and work spaces
 - Quarantine procedures and caring for sick students
 - Teaching “Best Practices” in personal hygiene and social distancing to our students
 - Physical classroom layout for social distancing
 - Assessing their own health and recognizing symptoms of COVID -19 in others

Student Training & Education:

- Students will be provided with training/education in the following areas:
 - Proper Hygiene
 - Proper coughing and sneezing into elbow or tissue
 - Proper handwashing with soap and water for at least 20 seconds
 - Proper use of hand sanitizer
 - What 6 feet looks like and the importance of social distancing

Arrival & Health Screening:

- Families are encouraged to take each student’s temperature and monitor any covid-19 symptoms at home each morning to avoid having their child sent home once arriving at school.
 - If you can answer YES to any of the following screening questions, your child should NOT come to school. Please contact your doctor for medical advice regarding testing or patient care, and then contact the school office.
 - Screening questions include:
 - Do you or anyone in your household have a fever, cough, diarrhea, rash on hands or feet or shortness of breath?
 - Does anyone in your household have any symptoms of a communicable disease like the cold or flu?
 - Do you live with anyone who has had close contact with person diagnosed with COVID-19 in the last 14 days?
- All students, staff, and parents entering the building will undergo mandatory temperature checks. Temperatures must be under 100 degrees to access the building. Face coverings are also mandatory to enter the building.

- Morning Arrival Access Points...
 - Grades 5-8
 - These students will enter the building through the Lafayette Street side entrance.
 - Grades K-4
 - These students will enter the building through the main welcome center doors
 - Preschool
 - Preschool students (and a parent) will enter the building through the playground (blue awning) entrance.
- Families should have an emergency contact who is available to quickly come get students who get ill at school.

Limits on Visitors:

- No parents or visitors in the school between 8:15-3:15 unless they are picking up a student or dropping off school materials, in which case they will utilize the school office.
- Preschool and kindergarten students are limited to one adult accompanying them to their class in the morning.
- Only one preschool parent/adult may enter the school to pick-up their preschool student.
- Parents of grade 1-8 students will not be allowed to accompany their child to their classroom in the morning.
- All building visitors will be health screened before entering the building, and will be limited to specific parts of the building based on the reason for visit.

Screening of Children During the Day:

- Students who do not feel well will be sent to the sick room in the school office. The office staff will screen the child to determine whether they may return to class, or need to be quarantined in the sick room until a parent or emergency contact can pick them up.
 - The sick room will be thoroughly disinfected after each student use.
 - Staff caring for sick children will do so with surgical mask, gloves, and face shield.

Testing & Responding to Positive Cases:

- Any staff or students that exhibit multiple Covid-19 symptoms (as determined by the school), including a fever, will not be allowed to return until they can provide a negative testing result from their doctor or other medical facility, or have been released from isolation according to CDC guidelines.
- Any staff or student that tests positive for Covid-19 will have to self-quarantine for up to 14 days until they are no longer infectious.
 - The school will notify parents of any laboratory positive or clinically diagnosed cases of Covid-19. Student/staff identities are always kept confidential according to ADA.
 - Students or staff members that are determined to have been in “close contact” of the positive case, will be asked to self-quarantine for up to 14 days or provide the school with a negative test.
 - Close contact definition...individuals that spent more than 15 continuous minutes within 6 feet of the positive case.

Personal Protective Equipment: (PPE)

- Guardian is providing one face mask for each K-8 student.
 - Face Masks
 - Students and staff members are expected to wear a face mask to school every day. Face masks will be worn while walking throughout the building and when social distancing cannot be maintained.
 - Students do not have to use the school provided face mask, and can instead substitute their own homemade or family purchased face covering.
 - Families are encouraged to wash/clean their masks daily at home.
 - Students in PS must wear a mask when they enter or leave the building and anytime they are in common spaces or hallways. While in their classroom or outside, preschool students will not be required to wear face masks. If a parent wants their preschool student to wear a face mask in the classroom, the child must be able to put on and take off their mask by themselves and leave it on without issue.

Cleaning and Sanitizing:

- Each room will be sanitized daily as part of our off hours cleaning.
- Each teacher will sanitize doorknobs, counters, and light switches periodically throughout the day.
- Water fountains will be used to refill personal water bottles from home only.
 - Refilling stations NOT active drinking stations
- Each classroom has a hand sanitizing station that will be used regularly.
 - Hand sanitizer stations will also be added to common spaces throughout the building.
- As part of classroom routines, students will be taught to sanitize their area under the teacher's supervision.
- All trash can lids will be taken away to limit cross contamination.
- The playground will undergo periodic cleaning each day.
- Rooms occupied by an individual that tests positive for Covid-19 will be closed until they are fully disinfected.
 - Cleaning staff will wear surgical mask, gloves, and a face shield while cleaning these areas.

Social Distancing:

- All classroom seats will be placed at maximum safe social distance and face one direction.
- Staggered hallway schedules will allow our students and teachers to avoid large mixed groups.

Food Service:

- Sharing of food between students is strictly prohibited.
 - This includes a temporary ban on birthday treats
- All classes will eat lunch in their homerooms.
- Guardian will still provide a hot lunch program, but additional steps will be taken to ensure the safe preparation and distribution of the food.

- No shared condiment items like ketchup, mayo, salt/pepper, etc. These items will be single serve packets.

Other Health & Safety precautions:

- Cohorting
 - Cohorting will be used in scheduling activities like physical education, recess, chapel services, etc. to reduce the chance for wide-spread illness.
 - The gym will not be used for recess. We will only use our outdoors space for recess. Alternative arrangements will be made if the weather does not allow for outdoor recess.
- Field Trips
 - No off-campus field trips will be scheduled during the first semester.
 - The only exception is the Leadership Retreat (Sept) and grade 6 outdoor education (Oct).
- Chapel Services & Assemblies
 - We will have weekly chapel services, but the format will include social distancing and cohorting. We will utilize live streaming to avoid large groups of multiple grade levels.
 - Assemblies will only occur if social distancing protocols (including cohorting) can be met, and will include only the grade level pertinent to the content.
- Lockers
 - Student lockers will be divided to accommodate social distancing when each grade level is utilizing them.
- Middle school classes will remain in their homeroom during core instruction, and teachers will move to them.
 - This is to eliminate large numbers of students in close proximity during passing periods.
- School-Home Communication
 - All school to home communication will be digital. The school will not use paper fliers to communicate information.
- Cougar Care (before & after school care)
 - Students will be cohorted to avoid mixing students from middle, elementary, and early childhood grade levels.
 - Snacks will not be allowed to be shared.
 - Remove a portion of toys to lessen the number of contaminated surfaces
 - Certain centers in the classroom will be removed to create more open space
 - Existing square footage ratios will continue to be followed
- Athletics & Extra-Curricular Activities
 - The decision to provide a sport and/or extra-curricular activity will be determined based on the health and safety of that specific activity and in compliance with the MHSAA. The school administration will make those decisions at the time of the sport/activity season based on real time information.
 - It is the hope of the administration that we will be able to offer as many sports and activities as possible; but this will be based on the ability to do so in a safe and healthy manner.

- If sports or extracurricular activities are offered, the school will follow the guidelines of the Michigan Safe Schools Plan.
- At Home Learning
 - Guardian will be prepared to quickly and seamlessly transition to At Home Learning for a short period of time if the State or Federal government mandates it.
- Schedules
 - Day and class schedules will be slightly altered to compensate for additional time lost to safety measures (see individual schedules).

New Temporary Employee Policies:

- Sick Day Symptom Log
 - A log of all symptoms causing a staff member to take a sick day will be kept in order to track possible Covid-19 outbreaks.

Addendum #1: Additional Preschool Restrictions

- Staff Precautions
 - Gloves
 - Gloves must be worn for the following tasks and discarded immediately after completing the task...
 - Assisting students in bathroom
 - Serving food
 - Placing and storing bedding
 - Handwashing
 - Frequent hand washing throughout the day
 - Mandatory hand washing after completing a gloved task
- Cleaning/Disinfecting
 - Frequent disinfecting of the following...
 - Bathrooms
 - Toilet Seats (after every use)
 - Counters/Sink
 - Mop floor with disinfectant if it becomes soiled
 - Cots & bedding boxes (after nap)
 - Tables (after each activity)
 - Light switches, door knobs, counter tops (periodically)
- Other precautions...
 - Remove all mouthed items for disinfecting
 - Bedding crates will be lined with plastic to fully contain personal items
 - Students wash hands after each activity change
 - Remove a portion of toys to lessen the number of contaminated surfaces
 - Rotate in and out these toys and disinfect when rotated out
- Class Size & Physical Spacing
 - Certain centers in the classroom will be removed to create more open space
 - Existing square footage ratios will continue to be followed
 - Extra outside time will be added to the daily schedule

- Only one preschool parent/adult may enter the school to pick-up their preschool student.
- Parents of grade 1-8 students will not be allowed to accompany their child to their classroom in the morning.
- All building visitors will be health screened before entering the building, and will be limited to specific parts of the building based on the reason for visit.
- Change from Stage 1 (phase 4)...
 - Parent volunteers will be allowed to begin working in the building, but will undergo the same screening to enter the building that staff members go through.

- Cohorting
 - Cohorting will be used in scheduling activities like physical education, recess, chapel services, etc. to reduce the chance for wide-spread illness.
 - The gym will not be used for recess. We will only use our outdoors space for recess. Alternative arrangements will be made if the weather does not allow for outdoor recess.
- Field Trips (CHANGE)
 - Off-campus field trips will be allowed under the following provisions...
 - All chaperones will be screened for temperature before transporting students.
 - Masks must be worn during transportation to and from the location.
 - Classes will abide by the restrictions of the field trip location including social distancing, wearing of masks, and sanitation procedures.
- Chapel Services & Assemblies
 - We will have weekly chapel services, but seating will reflect social distancing. Classes will sit with their homeroom, not in chapel families. Singing will still be part of chapel.
 - Assemblies will only occur if social distancing protocols (including cohorting) can be met, and will include only the grade level pertinent to the content.
- Lockers
 - Student lockers will be divided to accommodate social distancing when each grade level is utilizing them.
- Middle school classes will remain in their homeroom during core instruction, and teachers will move to them.
 - This is to eliminate large numbers of students in close proximity during passing periods.
- School-Home Communication
 - All school to home communication will be digital. The school will not use paper fliers to communicate information.

Screening of Children During the Day:

Continuation of the following Stage 2 (phase 5) policies and procedures...

- Students who do not feel well will be sent to the sick room in the school office. The office staff will screen the child to determine whether they may return to class, or need to be quarantined in the sick room until a parent or emergency contact can pick them up.
 - The sick room will be thoroughly disinfected after each student use.

Testing & Responding to Positive Cases:

- Rooms occupied by an individual that tests positive for Covid-19 will be closed until they are fully disinfected.

AT HOME LEARNING

“2020-21 At Home Learning – Phases 1-3”

At Home Learning: Implementation

This plan will be immediately set into motion based upon the governor moving Wayne County into phases 1-3. We will remain in At Home Learning until moved back into phase 4. There will likely be a one to two day “transition period” in order for teachers to load content and for school staff to distribute materials.

Learning Management System (LMS) Platform:

Grades 3-8 will use a FACTS LMS – Google Classroom integration. This platform utilizes all the benefits of Google Classroom, with the convenient integration into our FACTS LMS. These are platforms that our students have used before and should be proficient in using. Additional training on these platforms will be provided during the beginning of the school year to prepare students for the possibility of At Home Learning. Likewise, parent learning sessions will be provided so parents also know how to navigate and use this platform.

Daily/Weekly Structure:

- Grades 5-8
 - 1 Daily video communication per class
 - This video will communicate the desired outcome for the day’s lesson, along with any associated assignment. This is not the actual instruction.
 - Instruction/Assignments
 - Daily work (combination of instruction and assignment) for each class will not exceed 45 minutes (time for the **average student** to complete).
- Grades 3-4
 - 1 Daily video communication
 - This video will communicate the desired outcomes for all the day’s lessons, along with any associated assignments. This video will be longer than that of the middle school teachers, as it will be explaining all of the content area classes for that day. This is not the actual instruction.
 - Instruction/Assignments
 - Daily work (combination of instruction and assignments) for all combined classes should not exceed 3 hours (time for the **average student** to complete).

- Grades K-2
 - 1 weekly packet of coursework
 - Each packet will include a cover sheet with explanation/instructions for the week. If the teacher chooses to use daily instruction videos, then the cover sheet will remind parents to check their email for the video explanation.
 - All assignments for that week will be returned the following week when parents pick-up their new packet (or packets are distributed).
 - Instruction/Assignments
 - Kindergarten
 - Daily work (combination of instruction and assignments) for all combined classes will not exceed 3 hours (time for the ***average student*** to complete).
 - Grades 1-2
 - Daily work (combination of instruction and assignments) for all combined classes will not exceed 3 hours (time for the ***average student*** to complete).
- Preschool
 - Guardian will have the option of continuing our in-person preschool program (unless the governor strictly prohibits it).
 - At Home Learning Option
 - Parents will be provided with weekly emails from our teachers that include themes, engagements activities, videos, and many other resources.
 - Links to useful digital content will also be provided.
